

# NeuroRehabilitation Sunshine Coast Centre of Excellence Advanced Cervical Dystonia Convention, 30th March - 1st April, 2026 Ultrasound and Cervical Dystonia Course Pullman Port Douglas Sea Temple Resort and Spa

Registration is open to attend the NeuroRehabilitation Sunshine Coast Centre of Excellence Advanced Cervical Dystonia Convention, to be held at the Pullman Port Douglas Sea Temple Resort and Spa from 30th March to 1st April, 2026. The education event is a 3-day cervical dystonia ultrasound course which is exclusively open to accredited registrars and consultants in rehabilitation medicine and neurology. The course will focus on identifying muscles commonly affected in cervical dystonia with ultrasound. Salivary gland identification for treatment of sialorrhea will also be included. It is hoped that this workshop will assist you to develop the expertise and confidence required to offer treatment for these conditions in your clinical practice using ultrasound. No injections will be performed as part of this course.

It is expected that participants will already have a sound understanding of anatomy prior to attending the course. Teaching will be provided by Dr Warren Jennings-Bell, Dr Jom Jiao and Dr Juan Rois, who have developed expertise in performing ultrasound-guided botulinum toxin injections for spasticity and cervical dystonia.

The number of convention positions are limited and available on a first come first served basis.
